SUMMARY

The following Ordinance of the Township of Lakewood authorizes the sale of Township owned property pursuant to N.J.S.A. 40A:12-1, et seq., known as Lot 20, in Block 12.07, as delineated on the Tax Map of the Township of Lakewood. This property is vacant and is less than the minimum size required for development, being approximately 50' x 172', and is improved with one-half (1/2) of a residential structure, and is located in the R-12 Zone which requires 12,000 square feet for development. The Township Committee has declared that the property is surplus and is not needed for public use. Said Ordinance authorizes the sale of the subject undersized real property by private sale to a contiguous property owner for not less than the fair market value of said real property, and further outlines the restrictions, conditions and requirements of the sale and minimum price for bidding on the property.
