BE IT ORDAINED by the Township Committee of the Township of Lakewood, County of Ocean, State of New Jersey, as follows:

SECTION 1. That Chapter XVIII (Unified Development Ordinance) of the Revised General Ordinances of the Township of Lakewood, specifically Section 18-1112, Land Development Checklist, be and hereby is amended and supplemented as follows:
