SUMMARY

The following Ordinance of the Township of Lakewood authorizes the Township to vacate all of the right, title and interest of and to the public in a portion of a paper street known as West Spruce Street, as further outlined by description contained in the Ordinance, which portion of paper street remains unimproved, and is not needed for public road purposes. This portion of West Spruce Street is irregularly shaped and is in excess of the typical 50' width for Township rights-of-way. The Planning Board supports the vacation of this portion of West Spruce Street. The vacation of this portion of West Spruce Street lends itself to higher and better use than for public road purposes, and it is in the best interest of the general public and the Township of Lakewood that the rights and interests in and to same shall as a public right of way be vacated, released and extinguished.
