The following Ordinance of the Township of Lakewood authorizes the private sale and conveyance, pursuant to N.J.S.A. 40A:12-21, et seq., of Block 485, Lot 1, Block 486, Lot 1 and Block 490, Lot 17, to The Special Children's Center, Inc. Said lands are vacant and are not needed for public use. These lands are to be conveyed by Deed, for the consideration of \$120,000.00, to The Special Children's Center, Inc., with the restrictions that construction of the building must begin no later than two (2) years from the time of title transfer of the property to The Special Children's Center, Inc.
