

**AN ORDINANCE OF THE TOWNSHIP OF LAKEWOOD,
COUNTY OF OCEAN, STATE OF NEW JERSEY,
ESTABLISHING FIRST ENERGY PARK AS AN
AMUSEMENT PARK IN ACCORDANCE WITH
THE AMUSEMENT GAMES LICENSING LAW,
N.J.S.A. 5:8-100, ET. SEQ.**

BE IT ORDAINED by the Township Committee of the Township of Lakewood, County of Ocean, State of New Jersey, as follows:

SECTION 1. Lakewood Township hereby establishes First Energy Park as an amusement park.

SECTION 2. Any amusement games established at the amusement park shall conform to all federal, state and local licensing laws including, but not limited to the New Jersey Amusement Games Licensing Law.

SECTION 3. Each amusement license shall be filed with the Township Clerk and be subject to approval by the Township Committee.

SECTION 4. Upon proof of compliance with all applicable requirements, the Township shall authorize the issuance of a license by Resolution.

SECTION 5. The following amusements and/or games will be available at First Energy Park and will be licensed pursuant to Chapter IV of The Revised General Ordinances of The Township of Lakewood:

Basketball	\$150.00
Dart Game	\$150.00
Ring Toss Game	\$150.00
Knock Down the Cats Game	\$150.00
Goblet Toss Game	\$150.00


SECTION 3. All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

SECTION 4. If any section, subsection, paragraph, sentence or any part of this Ordinance is adjudged unconstitutional or invalid, such judgment shall not affect, impair or invalidate the remainder of this Ordinance not directly involved in the controversy in which such judgment shall have been rendered.

SECTION 5. This Ordinance shall take effect immediately upon final passage as required by law.
