

ORDINANCE NO. 2012-1

SUMMARY

The following Refunding Bond Ordinance of the Township of Lakewood provides for the refunding of all or a portion of various series of General Obligation Bonds issued by the Township, and issued to finance certain general improvements and an early retirement incentive program of the Township. In order to finance the cost thereof, negotiable general obligation refunding bonds are authorized to be issued in the principal amount not to exceed \$9,600,000.

SUMMARY

The following Ordinance amends Chapter 32 of the Code of The Township of Lakewood, entitled "Stormwater Management", by the deletion of Section 32-1.3, entitled "Prohibited Conduct", and replacing it with new Section 32-1.3, entitled "Prohibited Conduct", prohibiting the spilling, dumping, or disposal of materials other than stormwater to the municipal separate storm sewer system operated by the Township of Lakewood. This Ordinance is further amended by the deletion of Section 32-1.4, entitled "Exceptions to Prohibition", and replacing it with new Section 32-1.4, entitled "Exceptions to Prohibition", which outlines all exceptions, such as water line flushing and discharges from potable water sources, air conditioning condensation, irrigation water, including landscape and lawn watering runoff, flows from springs, riparian habitats and wetlands, water, reservoir discharges and diverted stream flows, residential car washing water and residential swimming pool discharges, sidewalk, driveway and street wash water, flows from fire fighting activities, and flows from rinsing of certain equipment with clean water, all as outlined in the Ordinance.
