Industrial Park:

- A few years back we took a section of the industrial park and had it designated as an Airport Business Commercial District (ABCD Zone). The Township Committee passed an ordinance adopting the ABCD as a commercial-only area.
- We've since been advocating that another portion of the Park be dedicated to commercial uses. Non-profits and educational facilities currently operating in the designated area would be "grandfathered" from the restrictions of the proposed commercial-only district. This "tightening" of uses is proposed to provide sustainability of the commercial / industrial nature of the park. If acceptable, the Planner will draw up a map and the defining language that would create a zone-within-a-zone that will govern future approvals. This would be good for the health of our park in going forward and maintaining the tax base.
